1. Preamble

WARNING! Your installation and use of the software or hardware products entail your acknowledgment and agreement of these terms of License Agreement. Be certain to read carefully and accept the applicable terms of this License Agreement before You install and use the Software.

2. Object

This document ("LICENSE") sets off the contents of the license granted to You by Alientech S.r.l. on the Software, provided that You have legitimately acquired it.

3. No disassembly

The Software is licensed as a single whole product, even if it were technically separable into its individual components. Under no circumstances, its individual components can be partitioned for separate use unless it is expressly authorized in this License or by the provisions of applicable laws.

4. Copyright

All rights to the Software and / or the contents of the Data Bank to which we grant You access (including, without limitation, all images, photographs, animation, video, audio, music, text, applet, and update), as well as the Software graphical layout, are owned by Alientech srl and are protected by the Italian and international laws on the subject.

All documentation provided in an analogical or digital form with the Software (including, but not limited to, user's guides, instruction and operating manuals) is subject to Copyright and may not be copied, photographed, reproduced, translated or reduced to any electronic media or machine-readable form, in whole or in part, without Alientech srl prior express written permission.

All rights of commercial exploitation and use related to the Software, the Data Bank and to what accompanies or completes them, which are not expressly granted to You under this License, are exclusive property of Alientech S.r.I.

Your use of the Software will not give You any rights or claims of any kind on the Software.

5. Software License

the Software will perform uninterrupted or error-free or that the defects in the Software will be corrected 4) that the Software will not damage any other software or hardware You use 5) regarding the use or the results of the use of the Software in terms of its correctness, accuracy, reliability, or otherwise.

8. Limitation of Liability
