# AlientechManager – Terms of use

#### 1. Preamble

The use of software and hardware product provided by Alientech srl is based, in addition to the Software License, also on the Terms of Use ("Terms of Use") stated below. Consent to these Terms of Use is required to install or use the Software. It is therefore necessary to carefully read the applicable terms and accept them before using the Software.

BY INSTALLING THE ALIENTECHMANAGER SOFTWARE (HEREINAFTER "SOFTWARE") AND USING THE POWERGATE3 DECODER AND / OR POWERGATE3+ DECODER HARDWARE PRODUCTS (HEREAFTER "PRODUCT") MANAGED BY THE SOFTWARE, YOU AGREE TO BE BOUND BY THESE TERMS OF USE. IF YOU DO NOT AGREE WITH ANY OF THE TERMS AND CONDITIONS IN THIS DOCUMENT, DO NOT USE THE SOFTWARE AND REMOVE IT FROM YOUR COMPUTER.

ATTENTION: The Software and the Product require constant data transmission to and from Alientech srl servers, therefore the Product only works if Your computer is connected to the Internet.

# 2. What is subject to these Terms of Use

Alientech srl provides a kit consisting of computer software (AlientechManager) and hardware products (Powergate3 Decoder and / or Powergate3+ Decoder) that allow the customization of Powergate3 User or Powergate3 + User devices (hereafter "Device"), of their firmware (hereinafter "Firmware") and of their management software (hereinafter "Software User"). The Device is intended only for the tuning of vehicles for competition purposes or for uses in racing circuits and off-roads.

# 3. Limitations of liability

Alientech srl specifically disclaims all liability for any consequence resulting from Your use of the Software, the Product or the Web Services provided by Alientech srl. You may use the Software and access the Web Services at Your own risk and discretion, and You are solely responsible for any damage to Your computer system, or third parties, or loss of data arising from the use of the Software and / or access to any Web Service.

Under any and all circumstances Alientech srl shall not be liable for damages to the vehicle of the User, or third parties, whether due to Firmware malfunction, hardware incompatibility or any other anomaly that may occur, incorrect use of accessories or use of non-original accessories not supplied by Alientech srl, one of its subsidiaries or affiliates or its authorized resellers, failure to comply with any instruction in the User's Guides or in the Operating Manuals or User errors.

Some ECUs may not fully correspond to the model researched by Alientech srl, supported by Software and Device Firmware and listed in the Vehicle List of the Software. Under no circumstances Alientech srl can be responsible to you or any third party for any damage, injury, loss or claim or cost of any kind and for whatever reason, arising from such lack of correspondence.

Furthermore, You declare to be informed and agree that software or hardware variations of the ECU may compromise the proper working of the Device or vehicle, clearing Alientech srl from all liability, of any kind and nature, in relation to any damage, injury, loss or claim or cost of any kind and species, caused to you or to any third party.

To the extent not prohibited by law, in no event shall Alientech srl be liable to you or to any third party for personal injury, or any incidental, special, indirect or consequential damages whatsoever, including, without limitation, damages for loss of profits, loss of data, business interruption or any other commercial damages or losses, third party claims, or breach of due diligence obligations arising out of or related to Your use or misuse of the Software or the Product, however caused, and even if Alientech srl, its subsidiaries and affiliates or a representative of Alientech srl has been advised of the possibility of such damages, loss, claim or cost.

The foregoing limitations and exclusions apply to the maximum extent permitted by the applicable laws in Your jurisdiction.

# 4. Contents and property rights

No authorization for the analysis or modification of the Software, of the Software User and the Firmware, or the analysis or modification of the Product or the Device or their circuit configurations, is provided. Disassembling the Product and / or the Device will void the warranty and may be dangerous.

Alientech srl owns and administers some or all the rights to the images and other copyrighted content in the Software, in the Software User, in the Firmware, on the Product, in the User's Guide and the Operating Manuals. Use of the images and other copyrighted content (including copying, reproducing, modifying, uploading on a network, displaying, transmitting, distributing, licensing, selling and publishing) is prohibited outside the provisions of this agreement.

You are expressly forbidden to translate the Software, User's Guides and Operating Manuals except with Alientech srl prior written authorization.

You are also forbidden to use or offer the Software through mirrors or host services or allow third parties to access the Software remotely.

#### 5. Your Content

The Software allows You to customize the Device Firmware and the Software User with Your own logos, images and files (hereinafter collectively "Content").

You hereby declare to own all the rights on the Content You upload in the Software, or to be legally authorized to use such Content.

Under no circumstances Alientech srl will be liable for any kind of damage caused to Your User resulting from bad translations of text strings associated to Firmware commands or for any damage to the User customer's vehicle resulting from files You modified and pre-load on the Device through the Software.

### 6. Data storage

The Software allows storing files, data and Content in the installation directory of the Sotfware created on Your computer. You should make periodic backup copies of the entire contents of this directory to protect data and as a precaution against possible operational failures.

Alientech srl does not provide a cloud service or automatic data backup and / or recovery procedures and cannot be held liable for deletion or loss of files or data stored on Your computer in the event of failures or malfunctions.

Alientech srl reserves the right to introduce new procedures or change how data is stored at any time in its sole discretion, with or without prior notice.

# 7. Updates

When you run the Software, it will automatically download and install the updates made available by Alientech srl from time to time.

By using the Software You agree to receive such updates from Alientech srl.

#### 8. Online Resources and Web Services

Software and Product have resources and functionalities (the "Online Resources") that require constant data transmission to and from Alientech srl servers, therefore the Software works only if Your computer is connected to the Internet and the Product is connected to Your computer.

You hereby declare to be aware that the violation of the commitments herein provided would entail commercial damages for Alientech srl and therefore cannot plead Your good faith in Your defense.

You are entirely responsible for maintaining the confidentiality of the information you hold for your account, including your password, and agree not to transfer your password, nor to lend or transfer the use or access to the Web Services offered by Alientech srl to any third party. You are fully responsible for any and all activity that occurs via your account.

### 13. Notices

Communications and complaints sent to a different address from the ones provided above will not be taken into account for the purposes of this agreement.

In the event that Alientech srl needs to contact You about the Product, Software, Web Services or Your account, You agree to receive notifications by email. You also acknowledge the full validity of such notifications and communications sent in electronic format and agree that they meet the legal communication requirements.

#### 14.Term and termination

These Terms of Use will become effective on the date you agree to them, i.e. from the installation, access and use of Software and Product.

The term of this contract will extend from the date of your agreement until the first to occur of the following: (1) termination of the contract as provided hereunder; (2) the date you cease to use Product and Software by uninstalling the Software and discontinuing all use of the Product.

Breach of one of the provisions of the points: 4) Contents and property rights, 5) Your Content, 9) Access to the Web Services, 10) Access Rights to the Web Services and use of the Online Resources and 12) Availability of Web Services and Online Resources, constitutes serious non-fulfillment of these Terms of Use and gives Alientech srl the right to terminate the present agreement if You, upon receiving written notice of default, do not comply with the provisions of these Terms of Use within 10 (ten) days from receipt of the communication.

Furthermore, You agree that Alientech srl will not be liable to you or any third party for any damage or disservice resulting from the termination of Your contract arising from breach or violation of the provisions of these Terms of Use.

Upon any termination of these Terms of Use for any reason, You must immediately cease using Software and Product. Upon termination Alientech srl will have the right to immediately deactivate Your account and suspend access to the Web Services.

### 15. Governing Law, Dispute resolution and Forum

This agreement is regulated exclusively by Italian law. The applicability of the United Nations Convention on Contracts for the International Sale of Goods adopted in Vienna on 11.04.1980 is expressly excluded.

For all that is not expressly provided for here, the provisions of Italian law apply.

In the event of any controversy or dispute that may arise in relation to the application, interpretation, execution, validity and violation of these Terms of Use will be competent - unless otherwise required by law - the court of the country where you reside, if You are to be considered "consumer" in accordance with current legislation, otherwise exclusively the forum of Vercelli, Italy.

# 16.Language

These Terms of Use are translated from Italian for local requirements only: in the event of a dispute between the Italian and any non-Italian versions, the Italian version of this agreement shall prevail.

# 17. Surviving terms

If for any reason a court of competent jurisdiction finds one or more provisions of these Terms of Use, or portion thereof, to be null or unenforceable, such provision(s) will be limited or eliminated to the minimum extent necessary and replaced by a valid provision that best expresses the intentions of these Terms of Use, so that this agreement shall continue in full force and effect. These Terms of Use contain the entire agreement between You and Alientech srl with respect to the use of Software and Product, and supersede all prior agreements, whether electronic, oral or written, between You and Alientech srl with respect to Software and Product.

Failure to enforce or exercise by Alientech srl any provision of these Terms of Use is not a waiver of such provision, or the right to enforce these Terms of Use; furthermore, any conduct between You and Alientech srl or any third parties will in no way modify the terms and conditions of these Terms of Use. No provision of these Terms of Use in intended to confer any right or remedy to third parties.
