# AlientechSuite Software License Agreement

#### 1. Preamble

IMPORTANT! Your installation and use of the AlientechSuite software (hereinafter "Software") entail your acknowledgment of and agreement to these terms of License Agreement. Be certain to read carefully and accept the applicable terms of this License Agreement before You install and use the Software.

## 2. Object

This document ("LICENSE") sets off the contents of the license granted to You by Alientech S.r.l. on the Software, provided that You have legitimately acquired it.

## 3. No disassembly

The Software is licensed as a single whole product, even if it were technically separable into its individual components. Under no circumstances, its individual components can be partitioned for separate use unless it is expressly authorized in this License or by the provisions of applicable laws.

## 4. Copyright

All rights to the Software and / or the contents of the Alientech Dashboard and all its related platforms to which we grant You access (including, but not limited to, all images, logos, trademarks, photographs, animation, video, audio, music, text, and applet), as well as the Software graphical layout, are owned by Alientech srl and are protected by the Italian and international laws on the subject.

All documentation provided in an analogical or digital form with the Software (including, but not limited to, user's guides and operating manuals) is subject to Copyright and may not be copied, photographed, reproduced, translated, or reduced to any electronic media or machine-readable form, in whole or in part, without Alientech srl prior express written permission.

All rights of commercial exploitation and use related to the Software, the Alientech Dashboard and to what accompanies or completes them, which are not expressly granted to You under this License, are exclusive property of Alientech S.r.l.

Your use of the Software will not give You any rights or claims of any kind on the Software.

You shall provide your full cooperation, where there was need, in order to ascertain Alientech srl ownership rights, meeting all obligations and fulfilling all formalities that may be appropriate for a better protection of Alientech srl rights.

#### 5. Software License

Alientech srl grants You a non-exclusive license on the Software, that You may transfer only within the limits set below.

You shall use the Software in accordance with the purpose for which it has been developed and marketed, and in respect of the recommendations of use and technical specifications provided by Alientech srl, and to the extent set forth in this License.

You are not authorized to lend, rent, lease, or sell the Software.

You may transfer the Software to a third party only in conjunction with this License Agreement and it will entail your loss of the right to use the software.

Consequently, each copy of the software in your possession must be immediately removed from any support that is in your availability.

Your transfer to third parties of the software and tools associated with it does not transfer to the new licensee any right to use the related services for the legitimate use of the software, such as access to the reserved area of the Alientech Dashboard and the Technical Support Service provided by Alientech srl. If the new licensee wishes to benefit from these services, they will have to directly contact Alientech srl and bear the related costs for the services offered.

Alientech srl hereby expressly disclaims any other warranty, condition, representation, or term—either express or implied—as provided by law, common law, custom, usage or otherwise, including (but not limited to) warranty of integration, merchantability, quiet enjoyment, satisfactory quality or fitness for a particular purpose, accuracy or compatibility.

Alientech srl does not warrant and make no representation:

- 1) That the functions included in the Software will meet your requirements.
- 2) That the operation of the Software will be correct.
- 3) That the Software will perform uninterrupted or error-free or that the defects in the Software will be corrected.
- 4) That the Software will not damage any other software or hardware You use.
- 5) Regarding the use or the results of the use of the Software in terms of its correctness, accuracy, reliability, or otherwise.

#### 7. Limitation of Liability

To the extent not prohibited by law, in no event shall Alientech srl be liable for personal injury, or any incidental, special, indirect or consequential damages whatsoever, including, but not limited to, damages for loss of profits, loss of data, business interruption or any other commercial damages or losses, arising out of or related to your use or bad use of the Alientech Software, however caused, regardless of their cause and the theory of liability (breach of contract, illicit act or otherwise). # 8. No reproduction

Any dispute arising out of the interpretation, execution and validity of these terms and conditions shall be subject – unless otherwise provided by mandatory law – to the venue of the court of your place of residence, if you are a "consumer" under the current legislation, otherwise the exclusive court of Vercelli, Italy.

You further agree this is the complete and exclusive statement of agreement between You and Alientech srl, and that it supersedes any previous agreement, oral or written, and any other prior proposal and/or communication in relation to the subject matter of this agreement.
